## A RESOLUTION ESTABLISHING RULES AND REGULATION FOR ALL PARKS UNDER THE CONTROL OF THE BOARD OF MADISON TOWNSHIP TRUSTEES

WHEREAS, On May 11, 1993, the Board of Madison Township Trustees passed Resolution 93-052, establishing the rules and regulations for Madison Township Park and Tuttle Park; and

WHEREAS, as authorized by Ohio Revised Code, Section 511.32, the Board of Madison Township Trustees wish to establish Rules and Regulations governing the use of all public parks under their control.

## NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF MADISON TOWNSHIP TRUSTEES THAT:

<u>SECTION 1.</u> The Board of Madison Township Trustees herby wish to repeal and replace all previously adopted Rules and Regulations which apply to Madison Township Parks.

SECTION 2. The Board of Madison Township Trustees herby adopt the *Rules and Regulations* as attached to and made a part of this Resolution as **EXHIBIT A**, as the *Rules and Regulations* which govern all parks under the control of the Board of Madison Township Trustees.

SECTION 3. That it is found and determined that all formal action(s) of this Board concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board and that all deliberations of this Board and of any of its committees that resulted in such formal action(s) were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4. This Resolution shall take effect and be in force at the earliest period allowed by law.

**BE IT FURTHER RESOLVED**, a copy of this resolution be forwarded to Terry Gerred-Ditchcreek, Fiscal Officer; Tim Brown, Administrator; Chief Matthew Byers, Madison Township Police Department; Paul Cook, Madison Township Service Department Supervisor.

## Park Rules for all Madison Township Parks As established by the Board of Madison Township Trustees Resolution 19-104

- **Rule 1:** Removal, destruction or disturbance of park property, equipment, buildings, associated appurtenances or natural features is prohibited.
- Rule 2: Climbing on buildings, trees, and fencing is prohibited.
- **Rule 3:** Littering or dumping of refuse is prohibited. All garbage will be disposed of in garbage containers.
- Rule 4: Fireworks, explosives, and dangerous weapons are prohibited.
- **Rule 5:** Alcoholic beverages are prohibited in all township parks, except special events inside Bill Stanton Park's Banquet Hall or Recreation Hall. Consumption of alcoholic beverages are not permitted outside of the Banquet Hall, Recreation Hall or parking lot at Bill Stanton Park.
- Rule 6: Camping is prohibited.
- **Rule 7:** Vending, soliciting, signs and bill posting are prohibited without permission of the Township Administrator.
- Rule 8: Unless otherwise posted, all township parks open at 6 am and close at 11 pm.
- Rule 9: Motor Vehicles left in the park after hours are subject to towing at owner's expense.
- (if leaving a vehicle overnight, please contact the Madison Township Police Department)
- **Rule 10:** Unless otherwise posted, Dogs/Cats must be controlled on a leash no longer than eight (8) feet. Exotic animals must be in appropriate cages.
- **Rule 11:** Beach Access is **ONLY PERMITTED AT MADISON TOWNSHIP PARK.** Access to the beach, swimming and use of boat ramp is done at your own risk.
- **Rule 12:** Motor Vehicles, bicycles. and pedestrians must use the established roads, drives, paths, walkways, and trails. **NO ATV's** are permitted in any Township Park.
- Rule 13: Fires shall be for cooking purposes only and contained in the provided grills.
- **Rule 14:** Use of the park pavilions in Madison Township Park and Tuttle Park are to be scheduled through the Madison Township Administrative Office at 440-428-5128.
