Brass and Mr. J. Boyle. Mr. Ungers, Zoning Inspector, was present. Mr. C. Bernard, Assistant Zoning Inspector, was absent.

Mr. Sill requested a motion to approve the minutes from February 8, 2024. Mr. Boyle presented a motion to approve the minutes from February 8, 2024 Regular minutes, seconded by Mr. Brass. With no discussion the minutes were approved:

Chairman Sill re-opened the public hearing for variance request #24-002. Mr. Ungers read the following report:

Applicant & Property Owner: Jack Avcin

Location of Variance Request:

Permanent Parcel #01-A-011-0-00-006-0

Property Zoned: A-1, Agriculture

The applicant is seeking a Variance in order to convert an Agricultural Structure into a Single-Family Dwelling. Variances needed in order to issue a Zoning Permit include: A minimum frontage reduction of approximately 10 ft. A possible minimum sq ft reduction for the existing structure. A possible minimum 2 car garage reduction. And an approximate 10 ft reduction for the minimum riparian setback.

The Neighbor/Applicant letters were mailed on January 30th, 2024 and the Public Hearing was advertised in The News-Herald Legal Section on January 30th, 2024.

The public hearing was opened on February 8, 2024. The board needing clarification on a few items tabled the hearing until this evening.

The Zoning Office received no response from anyone regarding this hearing.

Mr. Ungers informed the board that the applicant is not present tonight. The board decided it was in everyone's best interest to table the hearing for another month.
